"THE ART AND SCIENCE OF GOVERNANCE"

Introduction

The Global Energy Parliament held its sixth annual session of Parliament on June 12-13, 2015 in Madrid, Spain. The topic of the 2015 session was 'The Art and Science of Governance'. Distinguished international experts from many fields of society and sectors including Education, Science & Technology, Health, Environment, Law, Sustainable Development, Culture and others participated. The function was inaugurated by His Excellency the Ambassador of India to Spain, **Mr. Vikram Misri**, and the session was opened by **Dr. C.V. Ananda Bose**, Speaker of the Parliament.

The Good Governance Bill (Annexure 1) based on the address by His Holiness Swami Isa, focused on training decision-makers with the right awareness about the complex system of energy in which they and their populations are a part, in order to make informed decisions resulting in the wellbeing of all, and not some. The Bill was further supported by proposals from Lady Carla Davis, Dr. M.R. Thampan, Dr. Christophe Dumas, José María Márquez Jurado, Vibhu Garg, and other Members.

The Open Government Initiative Bill (Annexure 2) introduced by political scientist Dr. Fernando Vallespin Oña focused on the issues of how to guarantee a closer connection between a democratic government (or leadership) and the citizenry (or followers) in order to develop transparency, accountability, participation, accessibility, and public integrity. The Bill was further supported by submissions from Amb. Sergey Batsanov, Julien Gueguen-Carroll and Dr. Dirk Seeling.

Preamble

In support of the political outcome document of the 2012 United Nations Conference on Sustainable Development (Rio+20) in which it was agreed that the implementation of sustainable development goals to ensure the basics for all will depend on a global partnership for sustainable development with the active engagement of governments, as well as civil society, the private sector, and the United Nations system;

In agreement with the Government of India's promotion of "Good Governance" based on the philosophy of *Vasudhaiva Kutumbakam* (the earth is my home);

In further agreement with the European Commission's 2009 Report on '*Global Governance of Science'* by the Expert Group to the Science, Economy and Society Directorate which advocates a vision of global governance for the common good that invokes European principles of good governance and fundamental rights;

Affirming His Holiness Swami Isa's view that effective governance is the ability to correct imbalances at any level, created through a total awareness about individual energy arrangements and energy interactions,

Affirming His Holiness Swami Isa's emphasis on effective governance through awareness of, in particular the Matter, Energy, Space, Time and Information (Thought-based and Emotion-based) and Consciousness of any given issue or population;



Acknowledging that complete knowledge about oneself and one's world is inculcated through total education, and that the young generation/ youth be trained to have such an integrated outlook;

Emphasizing that such an awareness integrates objective and subjective knowledge and becomes conscious decision-making;

Reconfirming the "I theory" as a theory of everything is the correct scientific perspective to guide this work;

Affirming that the ultimate goal of everyone is Total Consciousness, defined hereby a) philosophically as the happiness which is sought by all beings and b) scientifically as the state of non-vibration;

Members of Parliament hereby resolve that-

1. National governments and related institutions to pass necessary legislations and make appropriate policy initiatives to ensure that 'Total Consciousness' becomes an integral part of the system of governance.

2. Every citizen to have the right and knowledge to live a Life of Total Consciousness (LTC).

3. International organizations, National Governments and related institutions to take effective steps to end competition in governance through systems and legislations which also ensure zero tolerance to corruption.

4. Harmonization, alignment for sustainability, and accountability amongst all stakeholders across sectors, inclusive partnerships and data revolution is critical.

5. A Steering Committee to be appointed to secure the safeguard and promotion of the values of Accountability, Transparency, Participation, Accessibility and Public Integrity in all governmental institutions and its practices and decisions. This Steering Committee to be instituted by a selection of Government and Civil Society Representatives that will allow for citizen's engagement on the 'Open Government initiative' by society as a whole.

6. Global conflict resolution to engage the active attention of the world under the framework of 'One Mother Earth' and a Global Steering Committee to be set up to resolve conflict in the world within a specified time frame.

7. Every child to be provided with Total Education (See Annexure 3), in order to create future governors/leaders who exercise:

- a. Efficient decision-making in the perspective of the complex whole
- b. Inclusive decision-making
- c. Critical thinking
- d. Creative ability
- e. Compassion
- f. Transparency
- g. Self-sacrifice
- h. Self-correction
- 8. Every child to have the right to inclusive and equitable quality education.

9. A Global Communications Committee be set up to provide information about the six ways of seeing the Universe, i.e., Matter, Energy, Space, Time, Information and Consciousness (See Annexure 4), to members of the executive, legislative and judiciary in all nations.



10. Democratic governments to embrace the importance of providing citizens with open access to technology, the role of new technologies in driving innovation, and the importance of building the capacity to use technology.

11. Good governance to form the basis of all actions to ensure health and happiness for all beings (i.e., Poverty, Hunger and Equity).

12. Recognize that women and mothers are influential governors in society, and to actively work on areas of action for the global realization of gender equality and women's empowerment. This can be achieved through gender-sensitive development strategies through a life course approach, ensuring equal education employment for all, promotion of a culture of peace and non-violence, global citizenship, full and effective participation for leadership at all levels of decision making, universal access to all public services including health and technologies.

13. Arts and culture are key to creating positive or negative change in the world, as they work primarily with thought and emotional energy. The need for arts and culture to be steered effectively, implemented in more schools in order to develop the capacities in every member of society to contribute positively in the world for global peace and security.

14. Security of pure food for all beings on Earth to be ensured, to maintain ecosystems, the biosphere and human energy for sustainable consumption and production patterns.

15. Ensuring the provision of the basic services to all (clean water, sanitation and health care) and the poor to become the core of governmental responsibility. National governments to introduce appropriate measures to provide affordable medical care to the needy implementing the right to health a fundamental human right.

16. Promote harmony with nature on the Planet Earth ("Mother Earth") in order to achieve a just balance among the economic, social and environmental needs of present and future generations. All cultures and civilizations to contribute to sustainable development, by protecting and managing the natural resource base and cultural diversity in the world.

17. Governments may recommend a requirement to implement programs and decisions which satisfy the requirements of being a) culturally, b) financially and c) environmentally sustainable, including programs such as :

a. Introducing in every country the 'One House, One Fruit Tree' project (Annexure 5)

b. Effective and efficient bio waste programs /waste management procedures in developing countries

c. Introducing gold-based currency to create a sustainable global economy (Annexure 6)

18. A global system of medicine and the art of healing based on the science of human energy, which is primarily rooted in the wellbeing of all life forms, should be promoted. Likewise happiness should become part of the index for medical treatment.

19. In order to both validate the effect of improvements and identify further improvements needed a Gross National Health Index is suggested. This GNHI should not only include measureable savings and costs of healthcare, but also represent the general state of health a population or community expresses it is.

20. Research and implementation of renewable energy sources like Sound Energy, which is reliable, sustainable, modern, non-polluting and feasible (Annexure 7) to be a top priority.

21. Scientific devices to be researched and developed which provide leaders with a clear mind for decisionmaking and also change negative energy domination to positive energy domination;



22. A high-level advisory group on governance under the UN Secretary General to develop inter-related recommendations with the focus on conflicts, universal and equal application (without exceptions and exemptions), strengthening and further develop international law, preventing corruption and enabling transparency and on promoting new culture and education.

23. Good organisational governance to be promoted and implemented through democratic decisionmaking processes with right and responsibilities (i.e., through a balanced scorecard) to support sustainable financial success and happiness of the people in organisations.

24. World peace and peaceful actions can come about by acknowledging the relationship between inner peace and outer peace, and the desire of all beings for the state of peace.
